Upon monitoring jobs at the McCormick Expansion Project for over two years, the Inner City Youth Foundation has witness only 17 unskilled labors hired out of over 4,000 projected for the project.

Chistine Perkins of Inner City youth said "I think we may have to close it down. All the money and we are not getting any of it."

The total cost for the project is estimated to be \$1,4 billion. The State of Illinois provides funding for McCormick Place operations through the cigarette tax and revenue from the Build Illinois Fund. Inner City has submitted 433 application second to the Mexican Community Organization of South Chicago with 641.

A total of 3,136 applications were submitted to the Metropolitan Pier and Exposition Authority (Authority) for minorities to obtain at least 25% of the jobs as of September 1993.

Inner City is also trying to secure Black contractors to obtain some of the subcontract work. Targeting Schal Bovis and Association, a general contractor working on the project, who has a poor rating in hiring minority unskilled workers and Black sub-contractors according to Inner City.

An analysis of past employment practice indicates, the Authority has found it difficult to implement aggressively hiring strategies designed to increase employment of minority and women workers, as reported by'the Chicago Urban League. "For two years going to the meetings," Jerkins said "the employment practices of the Authority continue to come under close scrutiny as a result of many complaints from community organizations." The analysis of hiring at McCormick Place and Navy Pier conducted by the Chicago urban League found dramatic racial disparities in employment by opportunities. A study found that African Americans are under-represented in high salary positions and over-represented in low positions whites hold more than 80 percent of all positions with annual salaries greater than \$50,000 or wages of more than \$20.00 an hour. Conversely, African American employees present nearly 80 percent of all full-time employees earning less than \$5.00 an hour. Furthermore,





Five Liquor Licenses Revoked in Area by City

Under Mayor Richard M. Daley's crackdown on liquor license violations, five in the Mid-South area had their's revoked during September and October of 1993.

To date, 153 applications have been denied citywide under the 1990 law created by Mayor Daley to give Chicago residents a greater voice in determining whether or not to grant new liquor licenses.Most of the violations were on the north and west side of Chicago.

The concern was addressed by residents at the 4th Ward town Hall meeting in October.

The City also has expanded its undercover police program - begun earlier this year - to stop sales of alcoholic beverages to minors. Known as STAMP (Stop Alcohol to Minors Program), it tested liquorselling establishments by sending underage customers into bars, restaurants, grocery stores and other outlets to attempt the purchase of alcoholic beverages.

Harold Washington Product of Grand Boulevard

"Not only could he (Washington) speak the King's English, but he had a working knowledge of the 47th Street dialect. Oh, yes he could... He never left home." Rev. B. Herbert Martin, Mayor Washington's pastor, Progressive Baptist Church, 48th and Wabash


One of his last appearances in the area was on September 22, 1987, for the Grand Boulevard Shopping Plaza at 55th and the Dan Ryan. On the day of his death (November 25, 1987) in the Oakwood community. Again it was for a ground breaking.

Literally, Washington did alot of groundbreaking in this community. He was born in Cook County Hospital on April 15, 1922, to Roy Lee and Bertha Washington. Roy was an attorney and minister in the area. He was also a leading precinct captain of the third ward.

Young Harold went to boarding school in Milwaukee after his parents were divorced. He returned to Chicago, and attended Felsental Forrestville Elementary schools while living at 47th and Michigan Ave. with his father.

He attended **DuSable High School**, where he was on the school's track team, winning a city championship in the late 1930's.

Washington was known as a book-



Harold Washington inherited his position as precict captain. He followed his father's path in politics and started his own, becoming asoldier of the Machine.

Washington worked closely with the late cogressman Ralph Metcalf (1st District now Congressman Bobby Rush). He began to win elections as his distinguished public public career provided leadership. He served as **State Representative (26th District)** from 1964 to 1976, and as **State** Senator from 1976 to 1980. He then served as **Congressman (1st District)** from 1980 to 1983. All of his positions served the Greater Grand Boulevard community.

As Washington became a critic of the Democratic machine, he split from it. In 1977, he ran for mayor against Michael Bilandic and lost, but his campaign helped him gain momentun citywide.

The political power of Blacks surfaced more during the election of Jane Byrne in 1979. Many Black political leaders realized the potential power and began and planning for a Black to win as mayor of Chicago.

When Byrne offended Blacks by replacing Blacks with whites of the Chicago School Board and Chicago Housing Authority Board, the people protested, During his five years of office, he surpassed the title of Black mayor, and became the Mayor of Chicago.

In spite of repeated confrontations with the alderman who opposed Mayor Washington, he was able to make improvements in the city which could be seen and felt across racial and class lines.

In the Grand Boulevard community, ill-repaired streets and sidewalks were being constructed. Social services were delivered as a new direction of the city was unfolding. As a reformer, his political agenda pulled a city coalition together.

Mature campaign support from then Alderman Bobby Rush (2), Dorothy Tillman (3), and Timothy Evans (4), along with other supportive city alderman, helped keep Washington's agenda soaring forward.

Washington was praised and deeply respected in the city. He maintained his popularity as a people's mayor. ("He changed the course of Chicago and its politics, opening the door for whomever it was right and just".)

His death touched Chicago like the death of Martin Luther King Jr. He was

Thanksgiving - I hate it! Gobble-gobble. The whole nightmare started with the arrival of those darn Pilgrims in 1622. From there turkey life was all downhill-to the chopping block.

My family of feathers had grown, and it looked like there would be no stopping us But then, the Pilgrims decided they'd give thanks to their God of Mercy for making it through the first cold hell in a new land. This began the slow demise of my plucked family. My name by the

Harold married Nancy Finch, his high school sweetheart in 1952. They never had children and divorced in 1961.

Like most youth he worked various odd jobs, becoming independeny early in life. As an adult, Washington was drafted in the U.S. Army and became first sergeant in an all black unit. After the service, he went to Rosevelt University, where he studied political science, and became president of the Student Council. He later attended Northwestern's law school in 1948.

After school he worked for his father's law office and became active in **3rd Ward Democratic organization**. His father lost a race for alderman in 1947 and died in 1953. "Enough is enough!" The leaders knew then it was time.

Washington was drafted to run to run as Mayor at Bethel A.M.E. church on 45th and Michigan. Led by Lu Palmer and the Chicago Black United Communities(CBUL), located on East 37th Street, as well as other organizations in the area, such as the Chicago United Front, the movement for Chicago's first Black mayor was on full speed.

The Voters Registration campaign was headquartered on 47th and King Drive in the Fuller Building. The neighborhood political organization was based at the Charles Hayes Center on 48th and Wabash.

Washington lead an outstanding campaign, which attracted worldwide press attention. He defeated Byrne and then State's attorney Richard Daley, and finally Bernard Epton, to become the first Black Mayor of Chicago. a product of the Grand Boulevard Community, a symbol long overdue for Chicago, but came in just the right time, and ended untimely for Black Chicago.

Grand Boulevard has been known to be one of the most poorest and most neglected neighborhoods in Chicago, but Mayor Washington has shown that it produced the best Chicago ever had.



AIDS in the HOOD

promises of treatments and cures. Everyone had an opinion on AIDS. Some believed God's wrath, a green monkey or a mad scientist brought AIDS into the world. The epidemic was here. How far along are we regarding AIDS?

AIDS stands for Acquired Immnuodeficiency Syndrome. You might here people talk about the virus or HIV (Human Immunodeficiency Virus). HIV is an organism, a "bug" which causes AIDS. This "bug" destroys your body's defense against diseases.

The flu might keep you in bed for a week or two. Afterwards you can return to work feeling great. Your body's immune system, an army which protects you, helped you to recover. For an HIV+ person who has a weak immune system, the flu is deadly.

You've probably heard of people who became "positive." How? Having sex with an infected person, sharing needles during drug use, delivering a child by an HIV+ mother, or receiving a transfusion with infected donated blood are ways to get the virus. These are the known ways. Some of us are still afraid to touch people, doorknobs or toilets seats. Fear and ignorance seem to spread faster than the virus or AIDS education programs.

Along with the other issues in the African American community, such as racism, poverty, unemployment, housing, infant mortality, etc., etc., etc...now you can add AIDS. African Americans out number European Americans in cases of AIDS. When you hear of the AIDS epidemic killing thousands of people, most of them are homosexuals and then Blacks. As of 1992, the Health Department's "AIDS Chicago" (third quarter, 1993) newsletter reported males are six times more likely to be infected than females in Chicago. For every ten men you meet it's possible six may be HIV+.

How does this relate to the African community? There is a large gap between the number of cases if AIDS between Black males and White males (60% to 10% for heterosexual males). For homosexual males they're closer: 60% (Black) and 86% (White). If you look at Black females compared to white females the percentages are near, with 30 to 23 respectively. No statistics were reported for homosexual females (the highest cases are still among White homosexual males).

Geographically, reported and diagnosed cases are highest in Grand Boulevard, Woodlawn, Douglas, and Washington Park for Chicago's South Side Black communities. The range was from 72 to 104 total known cases. In comparison, some North Side areas Chicago's South Side Black communities. The range was from 72 to 104 total known cases. In comparison, some North Side areas reported as many as 1,059 cases in the Lake View community.

When you drive through the South Side of Chicago, you're overwhelmed with billboards for alcohol, cigarettes, hair care products and sneakers. Where are the AIDS awareness promotional ads?

Vance Steven, AIDS counselor and Case Manager of Daniel Hale Williams Health Center on 51st and State Street views AIDS awareness campaigns needs to be more in line with the community as well as an increase in it.

"Pamphlet which are culturally sensitive are needed." said Steven, "Also pamphlets which just say have safe sex are not effective. The type of effective presentation for HIV education is needed for STD (Sexual Transmitted Diseases) as well.

The Kupona Network on 46th and Ellis is the primary source for AIDS education and support services in the African American community. Kupona's financially struggling but thriving. Danny Green, a volunteer at the network, said: "It's difficult to get African Americans to come to Kupona to see (the support and services) available."

If you look in AIDS support directories, you'll find more facilities on the North Side than the South Side of Chicago. Is this surprising? The North Side is where you'll see many AIDS education, AIDS awareness, safe sex, safer sex, no sex, no needles, no drugs and other AIDS campaigns on billboards. This may explain the large number of "reported" cases of AIDS in the White communities. When, in fact, the Black communities are more effected by the impact of AIDS. Are we to believe that most Whites are homosexuals?

When you hear about this inequality, you might wonder: "Who controls the money in the Black community and decides how much money will be spent for promotion and education?" For the South Side, where are the city, state and federal campaigns?

These questions should be addressed and answered. Let's take a wild shot. If you increase ads about AIDS in the Black community, more African Americans will become informed. Sexual behavior will change. Survival rates will increase. People will obtain more support and resources. Do you think it' ll work? More ads? Ask an advertisement firm or successful business person if it pays to advertise.

The next issue of *South Street Journal* will continue "AIDS in the Hood" covering resources available for Blacks.

Revitalizing Chicago's South Side" theme of CRA initiatvies for Omnibanc in Chicago

William T. Johnson, chairman of Detroit-based OmniBanc Corporation, a Michigan bank holding company, will met again with community organizations to outline his preliminary community reinvestment strategies and to discuss specific community needs. The meeting for November 22nd at Kennedy king College will be hosted by Mark Allen of the Black leadership Development Institute and State Treasurer Patrick Quinn.

Johnson last meet at Chicago Black United Communities (CBUC) office on 37th Street on November 2 and 13th.

This comes at a time when Johnson has a pending agreement to purchase Indecorp, Inc., the two bank holding company for Chicago's largest minority-owned financial institutions -Drexel National Bank (\$128 million in assets and Independence Bank of Chicago (138 million in assets). He is scheduled to file his formal application with the Federal Reserve Bank later this month.

According to Johnson, "A critical component of both the Federal application and OmniBanc's presence in Chicago is our involvement with and commitment to the communities served by Independence and Drexel". Johnson continue to say, "Therefore, I want to make certain that I have made myself available to all the appropriate voices, fully assessed community needs and have considered all avenues before formalizing any of my CRA programs. It is critical that the leaders of this community play an integral role in the formation of any initiatives that will serve to revitalize these neighborhoods as it will require all of us working together to make revitalization a reality. By discussing my CRA ideas now, prior to Fed approval, I am able to ensure that my strategies reflect the imput of those who live and work in the areas affected."

The November 22nd public meeting is part of an ongoing assessment pro-

cess undertaken by Johnson since beginning the acquisition process in July. To help facilitate this community outreach initiative on October 25th signed a partnership with Allen to more effectively monitor community needs. Allen accepted the charge of facilitating dialogue and encouraging community discussion when Johnson is unavailable.

"Bill Johnson and I, since August, have been discussing the idea of my involvement in his community outreach activities. I wanted to wait to see the specifics of his plan before I made the decision to get involved," stated Allen. "Now, I have seen his initiatives and firmly believe that he is working in the best interest of the South Side community and I am thoroughly convinced that he will follow through on his intentions. It is my privilege to work closely with him, ensuring that he is able to hear from all the leaders of the community while formalizing this important revitalization program."

Patrick Quinn, State Treasurer, told South Street Journal that both banks are below the ration in loaning funds to the community where they are headquartered at. Quinn stated "Drexel and Independence is below 50 cents to the dollar and the norm is 74 cents to the dollar. They both need improvement and the Omni-Banc Corporation is an opportunity for the two to define their lending status in the community. There are more currency exchanges in the area and there should be an alternative to them."

After Johnson discussed his preliminary community reinvestment initiatives with several area community groups and business leaders, Johnson will formalize his plan and field questions from those in attendance at the November 22 meeting. Specifics of this town meeting will be forwarded as they are finalized.



Mid-South Planning Commission, Six Initiatives for Neighborhood

opment Commission composed of area residents, block clubs, communitybased organizations institutions and businesses is a volunteer organization committed to improving, enhancing and maintaining the cultural heritage of the predominantly African-American population that lives and works in the Mid-South area.

The Mid-South area which includes Douglas Park, Grand Boulevard, Washington Park, and portions of the Oakland community, is a community of change. It is a community that is home to the luxurious mansions on King Drive, the new White Sox Park, Illinois Institute of Technology (IIT), as well as the housing developments of Stateway Gardens, Robert Taylor and Ida B. Wells.

The area is traditional characterized by poverty, crime, ill-health, crowed and poor housing conditions, with an abundance of vacant housing, However, despite all odds, the Mid-South planning and Development Commission has initiated a planning process that would once again turn the area into the beacon of economic and cultural vitality.

Three years ago a comprehensive initiative economic development funded by the McCormick Tribune

The Mid-South Planning and Devel- Trust Foundation and involving partnerships with IIT and the Chicago Department of planning and Development was developed to enhance the area. It was then that the Mid-South Planning Group was formed, which later became the MSPDC, under the guidance and direction of the committee"s leadership the community identified six initiatives that would strengthen the neighborhood.


- 1. Develop Mid-South residential com ponent through new construction and rehabilitation;
- 2. Promote the generation and distribu tion of money circulation within the community through the creation of jobs, business investments and en trepreneurship programs;
- 3. Improve public transportation access for the community for jobs, education, training and recreation;
- 4. Enhance and improve usage of parks, recreation facilities and open spaces;
- 5. Maximize the opportunities for Mid-South residents to attain greater education and independence::
- 6. Ensure that all Mid-South residents have access to quality affordable and comprehensive health care.

The partnerships with Drexel national Bank, IIT, Southside Partnership and others have helped the area develop and implement a strong economic revitalization plan. The most recent and significant accomplishment has been the completion of the "Black Metropolis" plan; a comprehensive study for the area bounded by 31st and 43rd Streets,m and the Dan Ryan Express to Cottage Grove. The Black Metropolis is a phrase used to describe the era of economic and cultural growth for African-Americans in Chicago during the 1930's This plan promotes income-generating opportunities, tourism and cultural identify.

Mid-South has secured a \$125,000 appropriation from the State legislature to help fund the initial stages of the project. Several buildings in this plan will undergo \$2.5 million of renovation. The Bee Building, located at 3647 S. State will be used as a branch of the Chicago Public Library as well as a state-of -the art Adult literacy center and historical for the Black Metropolis" memorabilia.



Operating from St. Elizabeth's Church at 4100 S. Wabash, Rev. Jones, Andrea Henlley and Tamsey Malone conduct youth development activities for approximately 125 disadvantage youth between 16 and 21 years of age. Serving the Robert Taylor Homes, State Way, Hartigan, Raymond and Crispus Attucks Elementary School and Phillips High School.

Still living in Grand Boulevard where she was raised, in a mansion at 3545 S Michigan Ave, Rev Jones is the youngest of seven children belonging to Harry (late) and Marella Jones.

She attended Raymond and Douglas Elementary schools, and Graduated from Phillps High School in 1979. She has taken college courses in social work at the University of Kansas and graduated from Loyota and the Theological.

Beyond her physical beauty and spiritedly appearance, Rev Jones is identified by the next generation as a person who exhibits concern for youth and knows how hard it is everyday for young people to survive out on the streets of Chicago. How did did you get started?

I would say was Harold Washington because he brought on a change, he bought on a message for us.


Most humble experience?

staff members got tired of seeing the youth being destroyed in the streets through the current "phony" political system, describe Harris.

"As a young person I began to take it personally " said Harris " We decided that 21st Century VOTE is the only way to bring about true change, especially for our black youth, through a political system where our voices can be heard."

Harris outlined the grassroot organization primary focus is to redirect young people towards positive change. The overall mission is to get the young people involved, and to clean up the community with programs, including food programs, voter education, voter participation, and voter registration.

Since its inception, well over 8,000 people have been organized with the active leadership of the organization, marching in the Chicago Loop on the education crisis.

They have been successful in electing their own and endorsed candidates to the Local School Councils.

Washington said "We anticipate on supporting and electing candidates in the March 1994 election for county and local representation for the Illinois General Assembly". He continued to they are also going to address the county and state offices.

Other issues 21st Century VOTE anticipate on getting involved in economic parity. Which include the construction industry, governmental contracts, and small and corporate businesses.

"We intend to really move in this area." said Washington. "In addition, you have Koreans and Arabs in our community taking our money, but some of the money could return to African American communities which is not happening."

One of the organization's most accomplishments was recent preventing Mayor Daley from closing down health clinics in African American communities. One of which was at 35th and Michigan and 47th and State Street.

African American clinics are badly needed for health care in our community." Said Washington. "We got involved due to it was only the right thing to do."

Washington continued by saying that their organizations main focus is to take care of home (Chicago) first. He said this organization is getting overall community support simply because they are making moves toward what the community wants, by inclusion of the community.




