# Lake Grove Tenants fight to own

Housing complex is opened to highest bidder.

Douglas - Lake Grove Village (LGV) is located next to Lake Meadows' housing complex and Ida B. Wells. It is viewed by its tenants as another case of community renewal with the potential of replacing present residents. Rents can go from \$567.00 to \$891.00 a month if tenants are not successful in their attempts to purchase the complex.

Questionable owners of Lake Grove again filed for bankruptcy, leaving many of the tenants there who submitted a proposal to purchase the housing complex confused and

suspicious of developers and the Department of Housing and Urban Development's (HUD) fair play.

By law, tenants at LGV would have priority in buying the property during foreclosure. But if bankruptcy is filed, the housing



submitted a proposal to Wellere, Gloria Wise, Dawn Allen and Kathy Wimms are resubmitting a second proposal to purchase the housing the court for residents to be able to own the housing complex.

complex is opened to bid purchasing to the highest bidder.

In 1973 the United Presbyterian African Methodist Episcopal Church (UPAME) started the housing complex with 489 units. Ten years later, UPAME would file its first bankruptcy proceedings. Due to faulty management at the housing complex, Travis Realty would turn over management to East Lake Management (ELM).

But in the latest bankruptcy proceeding, 1996, ELM, ac-

cording to Leroy Pannister, Vice President at ELM, has also "filed due to many problems at LGV from vandalism, drugs, gangs, many tenants not paying their rent." This, Bannister says, put ELM deeper in the red, and wanting out of their contract with LGV, they filed for bankruptcy.

According to Gloria Wise, President of Lake Grove Village Tenant Council (LGVTC), LGV has had several owners since its inception. The UPAME, Margaret

Higgenbottom, Travis Realty, Elzie Higgenbottom, Bruce Roset were owners of LGV.

With LGV presently in bankruptcy court under Judge Jack B. Schmetterer of the U.S. Bankruptcy Court, several organizations have been bidding for ownership: LR Development, ELM, Chicago Community Development Corporation and LGVTC.

Several reliable sources including Gloria Wise of LGVTC and Leroy Bannister of ELM

say that, "CCDC is now the forerunner in the bid for LGV, offering the best agenda to renovate and run LGV."

After the highly publicized fire in the winter of 1996, only 128 units of LGV were left. The fire cost \$3 million in damages and 4 lives that no one can put a value on. The fire, many of the LGV tenants are saying, could have been avoided by better building design and maintenance of the buildings.

Alderman Toni Preckwinkle (4) said, "I still continue to support LGVTC and Ms. Wise and their right to purchase LGV. The LGVTC has always had my support."

But many of the original supporters of LGVTC, said Ms. Wise, have backed out; namely Illinois Rep. Lou Jones(D), U. S. Senator Carol Mosely-Braun (D) and Congressman Bobby Rush(D).

Ms. Wise said "Rep. Jones sup-(Continued on page 9)



# Burris Enters Race for Governor

Speculation about whether Roland Burris wealth make a second bid for governor of Illinois was put to an end when he announced his campaign staff.

. Burris, who ran in 1994, lost to his Democratic opponent Dawn Clark Netsch who lost to Governer Jim Edgar. Edgar is speculated to run against Carol Mosely Braun for her U.S. Senate seat.

This time out Burris says he expects to win his party's nomination in the primary. "Four years have passed. The candidates are different and I am putting together a different campaign team", said Burris

. So far, Burris has named Hyde Park resident Delmarie Cobb as his director of communications, and political and media strategist Chris Sautter of Sautter Communications. Both Cobb and Sautter have strong credentials.

Most recently, Cobb served as press secretary for the 1996 Democratic National Convention. Before that she was the director of communications for Jesse Jackson Jr.'s congressional campaign in the 1995 special election. In February's special aldermanic, Cobb represented 17th ward Alderman Terry Peterson.

Sautter has advised and provided media services for dozens of Democratic candidates. He has also handle several successful issue campaigns, including the Gateway referendum in Cleveland that provided public funding for the new baseball stadium and basketball arena and several riverboat gambling referenda in Indiana. Before opening his own firm in 1992, Sautter managed the Washington office of Axelrod & Associates, a Chicago political media company.

Sautter says Burris has the best chance of winning against his opponents. "Burris starts his campaign as the most formidable candidate in the field. He is a proven vote-getter," explains Sautter. "He has a remarkable record of achievement and as advocate for the people of Illinois."

Burris began his political career with a cabinet position under Governor Dan Walker. He was the first African-American to win a statewide election when he became the state comptroller. Burris has beaten Republicans for state offices four times: 1978, 1982, 1986 and 1990.

Burris says despite who enters the race, he plans to run against Jim Edgar— the incumbent governor. "There has to be a change in leadership. Illinois is in a holding pattern," emphasizes Burris. "I have the experience, I have the vision to energize and move Illinois into the 21st century."

The gubernatorial hopeful plans to announce his candidacy offically after Labor Day.

## **Beat the Heat**

In the summer of 1995 one week of brutally-high temperatures in Chicagoland contributed to over 700 deaths, mostly homebound elderly. Little Brothers-Friends of the Elderly, offer the following summer heat emergency tips for the elderly: 1) Get to know your elderly neighbor. 2) Check in on elderly neighbors. 3) In a heat crisis: open the windows, use fans, get into an airconditioned room if possible; wear loose-fitting cotton clothing. "Cool Off." Take baths, sponge off, put wet cloths on your wrists; drink lots of water and pure fruit juices (sugar, caffeine and alcohol make things worse). "Emergency"-if you start to feel sick or weak, pick up the phone and dial 911. 4) Be sure elderly neighbors have food and liquids. 5) If you think someone is having a heat emergency, Act now -loosen clothes, cool the person. Dial 911. It is better to "butt in" and save a life than to allow a tragedy to happen.


# **Lake Meadows Tenants File Law Suit**

The 601 Tenants Council Inc.of Lake Meadows has filed a law suit against Lake Meadows Associates, Draper and Kramer, Inc. to prevent a major 340 townhouse development on the grounds of LM. The plaintiffs are tenants (10) in the 601 building The complaint asks the court for a judgment to prevent the conversion of the 601 building into condominiums.

The basis of the lawsuit is the 99 year lease which states that Lake Meadows is to be a medium income rental property. It also argues that the residents of LM are entrusted to carry out the will and covenant of the 99 year lease until the year 2059.

The Visions newsletter also reported that the attorney (s) for Lake Meadows Associates/Draper & Kramer had not filed an appearance or answered the complaint as of Friday July 18, 1997. In support of the townhouse development and the 601 building condominium conversion is aldermen Madeline Haithcock (2) and Toni Preckwinkle (4).

War on Drugs, as exemplified by its position that possession of crack should be considered ten times more serious that possession of cocaine. Rush noted that the discrepancy in mandatory sentences is a severe handicap to the war on drugs since crack is made from cocaine, and large scale dealers in cocaine actually receive leniency under the sentencing guidelines, while low-

level crack dealers fill the courts and jails.


The sentencing ratio question raises serious civil rights questions because crack cocaine is more common in the African American community, and powdered cocaine is more frequently used in the white community. The original 100 to 1 disparity was created by legislation enacted by Congress in 1986. The law required Federal judges to impose the same five year minimum sentence for defendants convicted of possessing 5 grams of crack or 500 grams of cocaine.

Another Note on Drugs:

A report indicated that the drug industry is more lucrative than the automobile industry.

# **Old Mapping of Minority Wards Upheld By the Courts No increase in Black Wards**

The old mapping of minority wards in Chicago was upheld by the federal court last month.

For more than six years a case had been sitting in federal district court here in Chicago involving the fight by blacks and Hispanics to stop gerrymandering of their wards, giving them equal representation at City

Judge Brian Duff ruled in Barnett v. Daley- the Chicago Ward Re-map Case is one of the worse scenarios of a court verdict coming down from a judge, especially of the magnitude of Judge Duff, many are saying.

The Committee to Preserve Voting Rights (CPVR), on December 24, 1991, filed a new map that would create twenty-two African-American wards, eight Hispanic, and seventeen white wards, along with three wards having no racial majority. The Chicago Tribune would support the judge's verdict, ignoring the blatant racism involved in such a decision on his part, CPVR said. The whole thing is no more than racial gerrymandering, giving the whites in Chicago a majority at City Hall and running the city. This is known as "Racial Gerrymandering/Vote Dilution," turning back the clock to Jim Crow days of yester-years.

This case should be appealed and no doubt will be if blacks and minorities in Chicago are to get their share of the

The appointment by President Clinton of Attorney John Schmidt as Assistant U.S. Attorney General, to the Number 3 job in the U.S. Justice Department overseering civil rights, as well as William Daley to Secretary of Commerce, the department that handles the U.S. Census, which is instrumental in making population count, will and has had a great impact on who or what controls City Hall and Chicago in the future.

Toni Preckwinkle, 3rd Ward Alderman said "This is a no brainer, for Judge Duff to reach a decision as he did is incomprehensible. It is only a decision by the court to keep white wards in the majority in the city and at City Hall."

Bruce Crosby of the CPVR said that "The court took too long to render a decision on a case that took six years, when it could have been ruled on in nine months. 1981 proved to us that racial gerrymandering is very much alive here in Illinois and Chicago. This case must be appealed and will

# **Development in Action-The Supreme Life Buildings**

he Black Metropolis Convention and Tourism Council (BMC&TC) is a not-forprofit organization whose mission is to facilitate and market the development of African-American heritage tourism destinations in Illinois. Specifically, the Council is dedicated to developing the Black Metropolis Historic District in Bronzeville as a pilot project and premier African American heritage tourism destination; a historic center of African-American business, culture and politics on Chicago's

The BMC&TC has acquired title to the Supreme Life Buildings on the corner of 35th and King Drive. The Supreme Life complex consists of (22,000) square feet, currently configured in 1 main 2-story building (8,800 sq. ft.), in 4 adjacent 2-story- row houses (4,000 sq. ft.), in a 5th, 3-story town home and (3,000 sq. ft.) in 1 two-story rear building. The Supreme Life Center is in a key location at the corner of 35th and King Drive at the gateway to Black Metropolis. Appropriate development of historic buildings is vital to creating a transportation tourism hub and gateway gathering destination to stimulate the burgeoning economics of the growth industries of tourism and telecommunication for the entire Mid South Community.

Development of the Supreme Life Building as an interactive community-based institution will provide an eastern anchor to the 35th Street Tech-



nology Corridor and augment the other technology based institutions like the Chicago Police Headquarters, Illinois Institute of Technology, Overton Hygenic Building/Bronzeville Institute and Chicago Bee Library. In itself, the Supreme Life Buildings are proposed as a Chicago landmark registered designation on the National Trust for

Historic Places, and from 1924 until 1991 was home to the first African-American owned insurance company north of the Mason/Dixon line. The property was most recently owned by John H. Johnson and was also the original home base of Ebony/Jet Publications.

The main goals of BMC&TC has been to complete a series of community outreach planning charettes to determine the highest and best development objectives for this important space. The resulting objectives are as follows: 1) development of the Bronzeville Visitor Information Center; 2) development of a retail and commercial complex whose occupants will offer merchandise and services relating to heritage tourism and the African-American cultural experience; 3) development of an interactive communications technological site and teleconference center (smart building) to store and disseminate oral histories, genealogical data and tourism information via CD Rom and kiosks.

The design of Supreme Life townhomes will also serve as display spaces for historic artifacts and exhibits related to the history of black business development in the Bronzeville community. In addition, the 5th townhome is projected to be redeveloped as a Bronzeville Historic House Museum.

Implementation of the above mentioned goals and objectives must be augmented by an action plan that will facilitate discussion on collaborative partnerships and the interrelated development of individual components of the institution. Once this plan document is completed, there will be a final colloquium to present

the plan to the community and receive public/private input on the whole development concept. From there, requests for development proposals can be issued and con-

struction can begin.



recently had the opportunity to talk with former Robert Taylor resident and now number 3 man to Board of Education CEO, Paul Vallas, Mr. Philip Jackson. Jackson has begun an innovative new program called the Black Star Project. Black Star was started in August 1996. The project is focused around two areas: 1) finance, business and investments. 2) education.

Mr. Jackson stated, "There are extensive monitoring programs in the Chicago Public Schools. We monitor young people in the 6th 7th and 8th grades in about fifty elementary schools."

This program is different because it focuses on parents. Jackson says, "We want to make sure that parents can really raise their children properly." This is the first parent conference. There are forty to fifty different exhibits, support mechanisms and resources to help parents help their children.

Parents need to sharpen their skills in order to help their children learn. Parents must involve themselves in every step of the child's development. We serve the very young children to the very old children. There are learning activities for the child and even airplane trips. This is a great resource for parents.

There are also employment projects that can can help direct kids to special vocations. We think that schools are starting to improve now under the new management team with Paul Vallas, the CEO of the Chicago Board of Education.

Believing that both parents are

crucial to successful child rearing, one of BSP's most important seminars concerns the role of the fathers and men in raising children. "We think the Black men need to become more involved in this partnership in raising children. It is not something that only women should do, it's not something only fathers can do. All Black men have a responsibility to raise children and play a nurturing role, even if they are no longer living in the home" Jackson stressed. "Even men who do not have children should help. For example, I do not have children but that doesn't mean that I'm not responsible in helping children to

receive proper guidance."

"There are many ways in which men can play an effective role in raising our children. Many African American youths (particularly young men) believe that athletics is the only way to escape the inner city". Jackson continued, "while it is impressive that these young men are willing to work so hard for a goal. Anyone who practices or studies anything for 25 hours a week will probably be good at that thing. Unfortunately, there are only 300 jobs as basketball players in the NBA and literally millions of young

men who think that their only ticket out of poverty and despair is basketball."

Reiterating a well known fact Jackson said, "Most of the teachers, principals and crossing guards are women. We need to put some strong positive Black male role models in our children's education. The Black man has not been present in our homes and schools and this is the cause of many of our problems."

Jackson continued, "The media contributes by encouraging these young men to invest their time and

energy where the odds of succeeding are a million to one (or higher). There are five billion people in the world and there is only one Michael Jordan. It is better (and probably easier) to study medicine, engineering, law or business than to be like Mike. The chances of succeeding are much better.'

These young men too often are shown professional

players as role models instead of American attorneys, doctors. business professionals, and enterpreneurs. For the past months. newspapers have been dominated with stories about Michael Jordan, Scottie Pippen, Mike Tyson and Tiger Woods, but the truth is that this country is driven by what happens on the business pages, not the sports pages.

Young African American men think that athletics entertainers will get them "respect and girls!" The media have responsibility to present a balanced and fair representation of what black men are and can be in this society.

The most important thing that young African American males can do with his life is to get a

good education. We must encourage these young men to practice mathematical calculations and scientific formulas much as they might practice dribbling a basketball. The African American Community must make education its top priority, Jackson concluded.

# National Equity Fund \$300 million investment For Non-profit Organzization to produce affordable housing

At a time when public resources for the nation's poor are diminishing, several dozen of America's leading corporations announced that they will invest \$300 million to produce afordable housing in Chicago and other cities across the country. Their commitment will be fulfilled by the National Equity Fund (NEF), an affilate of Local Initiatives Support Corporation (LISC), which uses the Low Income Housing Tax Credit to create nnual corporate investment funds.

In addition to Chicago, with approximately 50% of 1996 funds comnitted, other cities where nonprofit developers will receive equity include: New York City; Newark; Boston; Philadelphia; Detroit; Cleveland; Indianapolis; Atlanta; Greenville, MS; Puget Sound; and a number of cities in Minnesota, Connecticut and Rhode Island. The \$60 million California Equity Fund will invest in affordable housing developments in other cities.

This year's NEF and CEF investors from Chicago are Citicorp; City National; Home Savings of America and TCF Financial Corp.



The music filtering through the African village will reflect everything from the rich tradition of Africa, to the Caribbean sound of Reggae; from the sexy sounds of jazz, to the joyful noise of gospel; from the wail of blues to the gritty street rhythm of rap. The restaurants-a coffee shop and a soul food emporium -will also pay tribute the uniqueness of our heritage. And, the clothing at the various markets will underscore our cross-cultural fashion savvy.

As founder and producer of the "Bring It On Home to Me" Roots Festival, my mission has always been to bring that vigor back to the South side. To bring it back home to the roots; to its people, young and old. Today is a family day. A day of sharing. A day or passing music's torch to the next generation. That is what The Bring It On Home to Me Roots Festival is about. It's a time for reminiscing, enjoying ourselves, but also a time to reflect on how we can Bring On Home the economic vitality that we had then but vitally need now.

As you and our readers may know, Cook County p variety of services to the public, largely in the public: health care area. But like many other counties throu state and nation, Cook County's responsibilities are while it's funding remains static. We've added 183 prosecutors since doubled the State's Attorney's budget.

Cook County spends at least \$800 million a year mandated costs, two-thirds of which are for criminal ju contrast, the State provides only about \$300 million those costs.

That leaves County taxpayers responsible for half-billion dollars in state mandates. And the tacks on millions more in unfunded mandates.

Here are a few examples: \* requiring the County to with \$13 million more for residential placement of youth; \* mandating juveniles be tried as adults for certa but providing no pre-trial funds to hold them in our center, often for over a year instead of the usual c months; and \* a potentially costly new mandate to pay appeals court cases and another mandate to provide free for deadbeat parents in child support cases.

going to offer the TIF program in the area just as it knew it was going to make way for the new police station on 35th street. Mayor Daley informed his associates of the \$65 million development way in advance of public notice.

The same holds true for Alderman Tillman (3) in the development of the Lou Rawls project, and the homeowner who is about to do some rehab on the house

Alderman Troutman (20) was aware of the TIF program coming to the area and so was Alderman Preckwinkle (4). Everyone informed their associates (or community residents) of the business proposed on their turf.

When it comes to public funds, it should always be in the interest of the community the funds are supposed to benefit.

There are almost 200 groups in the Mid-South area providing proof of how much there is a need for their services. For most of them their vision will never leave, i.e., Black people working in Black neighborhoods as other ethnic neighborhoods display. All share the common goals of Black economic development. At first glance it is hard to imagine the groups have such a common vision.



# **A Statement On The Problems** of Poverty and Welfare Reform In The State of Illinois

Dear Editor;

As Protestant Christians, we believe that it is our responsibility to be engaged in the debate with our brothers and sisters who suffer material need. Few topics have generated as much recent attention as the current debate over welfare reform. While we acknowledge that changes in our social assistance programs may be long overdue, we seek intelligent reform rather than the destruction of those programs. We present the following statement of concern and response to that debate here in the state of Illinois. I. The Present Crisis. A. The economy of our state and of the nation is limited in the extent to which it can currently make adequatelypaying jobs available to all persons. B. The state of Illinois has been facing major budget problems for a number of years. As a result of these problems and of shifting political priorities, programs that provide support to low-income families and individuals have faced serious recent cut-backs. C. On top of these alreadyexisting state problems, expect new Federal welfare reform legislation will decrease future Federal funding to public assistance programs and to Medicaid, providing health care for low-income families and individuals. D. In the midst of these economic problems, Illinois contains a large number of poor families and individuals who are struggling to survive and for whom some of these programs provide the margin of support they need for their families. II. Statement of Principles and Specific Areas of Response. A. We must create and maintain a viable employment strategy, coupled with an ongoing social safety net for those for whom employment is not an immediate option. B. We must be realistic

about the budget implications of these policies. We cannot cut programs and income support and expect poverty to disappear. C. We recognize that government alone cannot provide a solution for the social problems that we face. Both our private sector and non-profit organizations must play an important role in dealing with the crisis that confronts us. D. We affirm the necessity of developing a coordinated and comprehensive strategy to fight the social problems of need that face our communities. E. We affirm the need for broad input in public decisionmaking about programs aimed at low-income individuals and communities, in particular, the need to consult the communities and the people that these programs will directly affect.

# **Ban on Billboards**

An Ordinance To Ban All Alcohol and Tobacco Billboards is lead by Alderman Terry Peterson (17th) argued before the City Council Buildings Committeethe need for an immediate oan to protect the welfare of minor children. Earlier this month, Peterson was joined by Alderman Danny Solis (D-25th) in introducing an ordinance to the City Council that would ban the advertising of cigarettes or alcoholic beverages on billboards, sides of buildings and freestanding signboards.

Peterson calls billboards "24-hours a day drug pushers". Father Michael Pfleger, a long time activist against alcohol and tobacco billboards and a resident of Peterson's wards, agrees. He says African-American and Hispanic communities are inundated with these billboards. Pfleger compares Peterson's wards with that of Ald. Bernard Stone (D-50th). He says Peterson's ward, which is one percent white, has 185 alcohol and tobacco billboards on display, while Stone's ward, which borders Evanston and is 73 percent white, has only 50 alcohol and

tobacco billboards. Peterson. "In Chicago, this is a critical issue af-

fecting the welfare and health of our young people-children are picking up the habits of smoking and drinking everyday".

Peterson says he is only continuing the fight started by others. He specifically mentions Henry Brown aka Mandrake, who died last year in a mysterious drowning accident. Mandrake received national recognition for his efforts to get rid of alcohol and tobacco billboards in African-American and Hispanic communities by whitewashing them.

WECAN also works to create home ownership opportunities for participants through their lease to purchase program, which allows participants some period of time to qualify for a mortgage while living in the home and taking responsibility for it.

Financial counseling addresses issues of credit, income and budget. The emphasis is on how participants can strengthen their application for a mortgage by clearing up past credit problems or saving toward a down payment and closing costs. In conjunction with the Five Year Family Plan, to expand the scope of issues which are addressed in strengthening participants' ability to acquire mortgage financing. WECAN housing specialist works closely with FaithCorp staff to facilitate a successful financial counseling partnership.

The program seeks to demystify the process of buying a home, making the process more accessible and less intimidating. This approach furthers WECAN's goal of promoting home ownership for families who would otherwise have difficulty buying a home.

As such, home ownership becomes a real tool for increasing economic self-sufficiency among families in Woodlawn.
