## The 2nd Great **Fire was** Black

Wednesday, July 14, 1999, marked the 125th anniversary of the 2nd Great Chicago Fire, known as the Black Fire.

The Committee to Preserve the History of Black Firefighters and Paramedics hosted it's Second Annual Celebration of the historical event at the Chicago Fire Academy, 548 West DeKoven.

The fire was of great magnitude, reported to have started at 4:30 pm, in the alley between 4th and Clark Street, near what is now Dearborn Homes. Nearly 1,000 buildings were leveled within a 3 block area from East to West, and 15 blocks from North to South: leaving 3,000 African Americans homeless.

The rich whites living east of State Street, and European Immigrants to the West, countless fires of suspicious origin forced Blacks to move south along State Street, to form the "Black Belt" on Chicago's south side.

Engine 21 was the only "Black" Fire Company in the city, located at 47th Elgridge Ct. (now 9th and Wabash).

In 1927, Blacks migrated from the South in large numbers and the members of Engine 21 were relocated into Engine 19's quarters, at 3444 S. Calumet Ave.

Under his leadership of Firefighter Kublai K. Muhammed Toure in 1994, he hosted a Cookout for Retiree's, at Engine 19s quarters. This experience moved him to look into some of the stories he heard about the



In the wake of the fatal shooting deaths of LaTanya Haggerty, 26 and Robert Russ 22, and just recently a killing of a youth in Harvey, Illinois, Chicago citizens will continue marches and demonstrations. The latest one will be from 64th and King Drive.

Many organizers hold the marches, meetings, demonstrations and hearings a result of Police Superintendent Terry Hiller recommendation to discipline four of the officers related to the Haggerty killing. 



Now tell me what does it seem like to you. The ethnic cleansing in Chicago is subtle and is done under the cover of fair housing and economic development. It is far more difficult to detect. Many say that most blacks that are being moved from existing housing developments are pushed to the south suburbs or even Gary, Indiana.

I submit to you the City of Chicago does not want a large number of non-productive black folks living in it. The city appears to be making the transition from renters to home owners in its new build program. In the final analysis, many black people that remain in the city will need a higher standard of income and overall revenue to remain here. If that is not ethnic cleansing, what is? Chicago is not only implementing a program to further maintain its representation as a racist city. It is becoming more class protective than ever before, however, now there are some black people that have really bought in to and are populating the class system. After all, it would be to easy to point out a city with no more black people living in it. A main problem that we're are now going to face is the growing black elite, who's power and influence appears to be growing.

On June 16, where a massive march took on the Chicago Police Department headquarters at 11th and State Street, led by the Revs. Paul Jakes of old St. Paul Missionary Baptist Church, Christopher Bullock, Rev. Al Sharpton and a host of other civil and community leaders, sought changes to avoid tragedies. Participants crossed ethnic, gender, and generation boundaries, coming out to stand against police brutality.

One participant in the march at Chicago Police headquarters, Robert Lucas, director of the Kenwood Oakland Community Organization feels the march was successful.

"It accomplished a few things. It served to wake up blacks and others that didn't march that there's a serious problem in Chicago that's affecting thousands of people. It also showed that some people aren't afraid to take a stand. And, most importantly, the march served as a training paradigm for young activists."

Like most people, Lucas feels that both officers should be indicted for the murders. He also believes that if the situations were reversed, the officers would have thought differently. "In Russ' case, the officer took an object and broke his driver side window, which had been tinted," Lucas continued. "What would the officer do if someone had broken his car window? Would he not try to disarm the person, who might be trying to take is life?"

As a former Sheriff's Deputy Court Officer, Oliver has long been concerned with the need for answers to the tragic problem of police brutality. Oliver strongly feels that the Chicago

U.S. Rep. Bobby L. Rush believes the Supreme Court made the right decision in June when they struck down the unconsitiutional anti-loitring ordinance. On state and national levels, Prior to the deaths of Haggerty and Russ, Congressmen. Danny Davis (7) and Gregory Meeks (D-NY) presided over a historic national hearing called by the Congressional Black Caucus (CBC) to examine the rise of police brutality in minority communities. Where from New York City to Riverside, California community activists testified calling for U.S. Attorney General Janet Reno to open a federal investigation into police brutality. The Chicago Sun-Times reported Rev. Jessie Jackson of Rainbow/PUSH has requested the same of Reno, which she did.

"What is happening African Americans and minorities today is reminiscent of the days of George Wallace, Bull Connor and Jim Crow," Rep. Davis said. "The actions of a few law officers has lead to increase tension between the police and the communities they serve."

Davis and the CBC will be holding another hearing on Saturday, July 31, to be held at Quinn Chapel AME Church, 2401 S. Wabash from 12 noon until 5 pm.

Oliver sees new and improved legislation as an important key in the fight against police brutality. Congressmen should be initiating new and stronger legislation. In addition, Oliver feels elected officials should be more proactive in dealing with community issues. As witnesses by his involvement in the Joseph Gould incident, Oliver says that elected officials "Need to be out there on the front line whenever citizens in their communities are up in arms about issues of police brutality."

Wallace "Gator" Bradley, community activist and founder of United In Peace, a non-profit organization, also participated in the march. Bradley feels that the Rev. Al Sharpton's visit has helped make police brutality "a national issue". He's currently in talks with "The Jerry Springer Show" and "The Oprah Winfrey Show" about possible segments on police brutality and prosecutorial misconduct.

Paris Thomas, of the Community Vanguard, who has demonstrated at the mayor's office for a week everyday charged the community to be consisted with pressure on the city.

Thomas said the problem is the whole racial structure of the police department. "There is is about 2,300 black officers compare to 13,000 of the force. It is still racism that the two officers involved in the shooting are black. Black officers are condition that it is okay to harass the Black community. It do not happen in the white community as it does in ours."



Rep. Davis said that he may introduce legislation that would withhold federal grants from those police departments who fail to fully respect human rights.

In addition to Davis's actions Con. Bobby Rush has taken steps requesting the immediate funding and implementation of a national study that will accurately reflect incidents of police use of excessive force.

Rush committed to keeping this issue on the front burner of the national agenda, particularly, in light of the recent highly publicized reports of police misconduct.

Organizations from Bronzeville and citywide testified in support of BMCTC. Including Partners in Community Development, Mid South Planning and Development Commission, the Gap CDC, Community Workshop on Economic Development, Centers for Neighborhood Technical, Chicago Historical Society, and even the City's Dept. of Culture Affairs.

However, the Commission voted in favor of the Department of Planning with the insurance that the building will not be demolish, paving the way for the city to acquire the property at fair market rate and go forward with the development.

The city would use the same concept created by BMCTC, which calls for a Visitors Center as a catalyst for other commercial development.

Lucas said, "We wanted to create an international African American Heritage Tourism designation and visitors information center that had the potential to generate more than \$200 million a year in new revenues, which could create jobs, alleviate poverty and reinvent government."

Lucas has charged the city of engaging in a land grab by approving legislation to seize control of the old Supreme Life building. "The hearing was not about our mortgage-lender," Lucas said. "It was more about whether we have the capacity to do the project."

Cynthia Williams, a wealthy West Sider who loaned BMCTC \$150,000 to help purchase the site, testified she put up \$90,000 for delinquent taxes. She supported the city and the CDC's position to take over the project, upset that Lucas did not repay her.

"If the City develops the Supreme Life Center Project, there would be no partnership, or ownership by residents, and the project would be 100% financed by tax dollars.

According to Lucas the city will use the same 5 dollars from the private sector for every dollar of EZ funding. BMCTC has generated over \$600,000 in private sector investment in the project.

Another hearing was heard on July 1, by the City Council's Housing and Real Estate Development Sub committee preparing to be heard and voted on before the full City Council.

BMCTC is appealing to Vice President Al Core and his National Empowerment Zone executive director, Alvin Brown to act on the project to be consistent with EZ basic principles: a bottom-up relationship between the government and communities.

The organization will also appeal to the National Black Caucus and file a complaint with the Department of Housing and Urban Development General Office, for a class Action suit to complete the acquisition.

Supreme Liberty, later known as Supreme Life) in 1929 was the merger of three Black companies....Supreme Life and Casualty of Columbus, Ohio; Liberty Life of Chicago; and Northeastern Life of Newark, New Jersey. The merger combined a joint business in force of \$27 million. This was one of the first major mergers in American business history, and it was at that time the biggest financial deal ever negotiated by all-Black business ... -- John Johnson. Seventy years after this historic merger, and six years after the corporation was liquidated, the Supreme Life Insurance Company is still the center of controversy.

Beauty: "Do you know what the House bills are?" Queen Sister could you please state what then House Bills are?"

Queen Sister: "Blessing," its a honor to be blessed with your present. We are the Village People Organization are dealing with the Robert Taylor Village issues - and the Bills



Beauty; "Thank you very much Queen sister! "We would like to know Joe, "What do you feel about these Bills?"

A "These are Bills that we supported, we are faced with situations about people that are being released from jail and are returning back to C.H.A. areas, we are asking that we be notified about it, "because it might jeopardizes the other tenants.

Beauty: "Don't you feel that the people that's being released have already served their time, and don't you think that if those people came back to C.H. A., it shouldn't effect the leaseholders rent or their ability to stay there?" A "It depends, what if the person is a sex offender, or have committed a crime on a child!".....And as for the rent, it's base on your income, if a person have no income it stays the same, but if a person comes into your home, then it must be reported and documented.



Section 8 for C.H.A. - Congress has issued new Section 8.

Section 8 is more likely to last longer then public housing!"

Beauty: "Do you think the relocation plan is working?'

A "I think that we have gone to building and ask people what was their desire, what was their housing choice?"

And so far a large respond wanted Section 8. Beauty: "How many people hae been successful?"

A So far about 80 percent, but that's not their only options - we asked them, the people, if they wanted to stay, they may go to other units, but we don't know how long that's going to last!"

Beauty: "It was a big problem concerning heating in C.H.A. Robert Taylor Homes, back in January. Could you tell my readers how did you feel about that?"

A "I think because of things like that is why Congress takes the position it does, the fact of the matter is the way the buildings are, the cost of maintaining them are very hard, then what do you get back?'

When Robert Taylor was build, it had a central heating problem, it had open valves that made it optional to vandalism!"

Beauty: "What is your visions concerning C.H.A. 10 years from the day?"

A "I think the main thing would be that we have more housing opportunity for families in communities in housing that they would like to live in . "I think that too much of our housing people live in is because they don't really have a choice."

Mr. Joseph Shuldiner, the next voices that you will hear is from the ones that it is effecting the most, and that is the Resident and Tenants of Chicago Housing Authority Development!" And then you will be the judge, are these things being done for our benefit or for their own selfish greed?"

Dear Mr. Carter: The movement against the U.S./NATO war in Yugoslavia

and against U.S./U.N. sanctions on Iraq is growing. Since the NATO bombing began, peace organizations in Chicago have organized three protests and participated in well over 20 forums and teach-ins to date. And Chicago has long been a hotbed of anti-Iraq sanctions organizing, intensifying since last December's bombing of Iraq and subsequent protests and public forums.

Two major protests held in June: on the 12th at the University of Chicago, President Clinton give the commencement address, and on the 18th at Northwestern University in Chicago, Secretary of State Madeleine Albright was to speak and receive an honorary degree of international law.

Graduating students from both universities made known their opposition to Clinton's and Albright's policies, and to their universities' decisions to invite them as commencement speakers. Outside the graduation ceremonies, thousands of protesters from around the Midwest gather to call for peace in Yugoslavia, and for an end to the sanctions that kill over 200 Iraqi children each day. To raise awareness and build support for the demonstrations on the university campuses and in the wider community, a fast included a component at the University of Chicago. The Reverend Thomas Gumbleton, the auxiliary Bishop of Detroit, participate in the fast on June 17. Other activists from around the country and the Chicago area joined in the fast .A fast began May 24th at Northwestern University, and continueed through the June18 protest. The action also included a component at the University of



Chicago.

Local organizations participating and accompanying fasts included the Eighth Day Center for Justice, Pax Christi - Illinois, American Friends Service Committee, International Socialist Organization, Prairie Fire Organizing Committee, Voices in the Wilderness, and Illinois Peace Action, among others. ## Urban cleansing of those previously mentioned people

n response to a front page article in the MetroChicago section of the Chicago Tribune on June 14, 1999:

"Ticketing of owners helps city seal vacant buidling," this article is not necessarily an indictment of the city, it raises questions about issues centering on the fast-track demolition of buildings in the Bronzeville community.

These issues were presented to the city in 1996, by the Alliance for Neighborhood Preservation, a group of Bronzeville residents, Friends of Bronzeville, and a member of Habitat for Humanity; and, the Bronzeville Organizing Strategy Sessions (BOSS). I strongly urge readers to consider this as questions seeking real answers.

So, the city has found "a new plan to go after vacant buildings, which often promote crime." This new plan involved writing "highpriced" tickets to owners of unboarded vacant buildings - up to as much as \$500.00 per day instead of the more expensive method of taking owners to Housing Court. While nearly everyone may agree that this is an excellent plan, I happen not to believe that its a new plan. The City of Chicago had been under attack for its fast-track demolition program until most recently, now that communities on the southside (in the Bronzeville area (Douglas-Grand Boulevard Kenwood-Oakland, and Washington Park) have been served a menu of green space/ brown space/and litter space, where once stood reusable buildings, many of them solid, needing only to be made available through the city's highly publicized CAPS program. No housing stock, no CAPS plan!

Now that those desirable area have been significantly cleared of "obstacles", making possible new development for an influx of fresh residents, the city has suddenly found a new plan that makes it possible to keep buildings while supplying the city with a fresh stream of dollars: Now that would qualify as a "New Plan," to acquire properties via fine-induced insolvency. Who is the architect of this plan?



What's tragi-comical, is that many people, especially African Americans, who've sought information on housing from the city have been steered to the Engelwood and Roseland communities, frequented the news with numerous tales of crime.

Are these communities the in-city alternatives to the suburbs as a repository for those who either can't afford to move into, or stay in the more coveted communities along the lakefront... where the overdue promise of creating median enhancements for traffic safety and aesthetics on par with the northern lakefront are now scheduled for within the next four years? Seems like the city wants to upgrade

the physical landscape consistent with the continuing changes in the human populace!

Whether or not shared by any others, that what we are seeing in specific areas. such as Bronzeville; parts of the Uptown communities; and, different neighborhoods on the westside, and urban cleansing of those previously mentioned people who are ethically, mentally, physically, and/or economically different) Those ugly people whom many Americans don't like to be around, or even see. Nothing personal, not war, just politics.


